Terms and Conditions

We are excited to announce the launch of the Live on Sunshine campaign.

How it works:

1. The promoter

- The promotional prize draw is promoted by Tesla Motors Australia Pty Ltd (ABN 68 142 889 816), 546 Gardeners Road, Alexandria NSW 2015 (Tesla).
- Authorised under NSW Authority No. [NTP/11523], ACT Permit No. [TP 24/02570] and SA Licence No. [T24/1985].

2. The competition

- No purchase necessary.
- The competition is open to anyone who meets the Eligibility criteria and fills out the competition form, as described in section 3.
- Duration: The competition will start on Monday, November 18th, 2024, and close at 11:59pm AEDT on Wednesday, April 30th, 2025 ("Competition Period"). For you to be eligible for the competition, your entry must be submitted within the Competition Period.
- By entering the competition, you hereby warrant that all information submitted by you in your entry is true, accurate and complete in every respect. Tesla reserves the right to verify any information contained in your entry and/or your eligibility to enter the competition.
- Tesla will not accept:
 - responsibility for competition entries that are lost, mislaid, damaged, or delayed in transit, regardless of cause, including, for example, as a result of any equipment failure, technical malfunction, systems, satellite, network, server, computer hardware or software failure of any kind; or
 - o proof of transmission as proof of receipt of entry to the competition.
- Tesla reserves the right and discretion to disqualify any entrant if it has reasonable grounds to believe that an entrant has breached any of these terms and conditions or any applicable law. Each entrant acknowledges and agrees that any failure to comply with these terms and conditions could lead to Tesla disqualifying that person, without Tesla giving any reason for such disqualification or granting any opportunity for challenge.
- In the event that a prize-winner is disqualified from the competition, Tesla will select an alternative prize-winner in the same manner as the original prize-winner and such selection will be subject to these terms and conditions. By submitting an email address, entrants are agreeing to subscribe to Tesla's mailing list. The entrant can unsubscribe at any time.

3. Eligibility

- Only open to Australian and New Zealand residents, aged 18 and over who are able to take the prize between Friday, May 2nd, 2025 and Sunday, November 30th, 2025 who is a private homeowner (free-standing, semi-detached, terrace, townhouse or other property owner with sole and exclusive development rights over the relevant independent roof section to support solar, with individual parameters with a low-voltage grid connection). Participation is only possible through the Live on Sunshine website at this URL Tesla.com/Live-on-Sunshine.
- Directors, officers, management, and employees (and the immediate families of directors, officers, management, and employees) of Tesla and agencies associated with this promotion, are ineligible to enter.
- To enter, visit Tesla.com/Live-on-Sunshine and fully complete and submit the competition entry form, including providing your full name, address, email address, phone number, and any additional information as required by Tesla.
- By entering this competition, participants agree to our terms and conditions and to be contacted by a Tesla Certified Installer.
- You can only enter once per person per household. Prizes are awarded at Tesla's discretion.

- Customers who submit an entry, complete their installation, and register their Tesla energy system with Tesla within the campaign timeframe, will triple their entries to win and be eligible for reimbursement of their system and installation costs, up to \$25,000 AUD.
- If you are selected as a winner, you will receive a reimbursement for the cost of these products and their installation up to the value of AUD \$25,000, subject to you providing evidence of your purchase of these products. For example, if you had a Powerwall 3 already purchased and installed during the campaign period, we will reimburse you for the cost of this Powerwall 3 and its installation, up to the value of AUD \$25,000.

4. The prize

- 1 winner in Australia and 1 winner in New Zealand will each receive:
 - a. a solar system (up to 13kW),
 - b. a Powerwall 3,
 - c. a Gateway,
 - d. a Wall Connector, and
 - e. the installation of the above products
 - up to a combined total prize value of AUD \$25,000.
- Each winner will also receive the free use of a Model 3 or Y for 10 days ("Car Hire").
- Tesla will not cover the costs of remedial, upgrade works to the building structure, electrical circuits or switchboard in the event that works are required to enable the installation of the system, and unrelated to the actual PV and BESS itself e.g. roof repairs, meter switch box upgrades etc. The prize does not include obtaining any applicable permits, authorisations, registrations, notifications, exemptions, approvals, and other authorisations obtained from or made with any governmental authority ("Permits") or associated costs with obtaining such Permits.

5. Winner announcement

The winners will be chosen through an anonymous and automated data selection process. All prizes including unclaimed prize draws will be drawn from this location.
- The unclaimed prize draw will be drawn at Tesla Motors Australia Pty Ltd, 546 Gardeners Road, Alexandria NSW 2015 at 10am AEDT on Friday, May 16th, 2025.
- The announcement of the winners will be via email by Friday, May 2nd, 2025 ("Announcement Date"). The winner of any draw will be notified in writing within seven days of the prize draw and any unclaimed prize draws.

6. Claiming the prize

- If you are the winner of the prize, you will receive an email or be contacted by a Tesla employee notifying you that you have won and details on how to claim your prize.
- Winners will have 14 days from the Announcement Date to claim the prize. If, after making all reasonable attempts, Tesla cannot contact a drawn winner (and the drawn winner does not contact Tesla to claim the prize) within 14 days of the Announcement Date, Tesla reserves the right to discard that entry and to draw another winner, who will be given 14 days, to claim the prize.
- The prize may not be claimed by a third party on your behalf.
- Tesla will make all reasonable efforts to contact the winner.
