

## Live on Sunshine

### Terms and Conditions

We are thrilled to announce the launch of the Live on Sunshine campaign.

How it works:

#### 1. **The promoter**

- The promotional prize draw is promoted by Tesla Motors Netherlands BV, Burgemeester Stramanweg 122 (1101 EN), Amsterdam Netherlands (Tesla).

#### 2. **The Competition**

- No purchase necessary.
- The competition is open to anyone who meets the Eligibility criteria and fills out the competition form, as described in section 3.
- Duration: The competition will start on Tuesday, November 18<sup>th</sup>, 2024, and close at 11:59pm CET on Wednesday April 30<sup>th</sup>, 2025 ("Competition Period"). For you to be eligible for the competition, your entry must be submitted within the Competition Period.
- By entering the competition, you hereby warrant that all information submitted by you in your entry is true, accurate and complete in every respect. Tesla reserves the right to verify any information contained in your entry and/or your eligibility to enter the competition.
- Tesla will not accept:
  - responsibility for competition entries that are lost, mislaid, damaged or delayed in transit, regardless of cause, including, for example, as a result of any equipment failure, technical malfunction, systems, satellite, network, server, computer hardware or software failure of any kind; or
  - proof of transmission as proof of receipt of entry to the competition.
- Tesla reserves the right discretion to disqualify any entrant if it has reasonable grounds to believe that an entrant has breached any of these terms and conditions or any applicable law. Each entrant acknowledges and agrees that any failure to comply with these terms and conditions could lead to Tesla disqualifying that person, without Tesla giving any reason for such disqualification or granting any opportunity for challenge.
- In the event that a prize-winner is disqualified from the competition, Tesla will select an alternative prize-winner in the same manner as the original prize-winner and such selection will be subject to these terms and conditions.
- By submitting an email address, entrants are agreeing to subscribe to Tesla's mailing list. The entrant can unsubscribe at any time.

#### 3. **Eligibility**

- Every homeowner ((free-standing, semi-detached, terrace, townhouse or other property owner with sole and exclusive development rights over the relevant independent roof section to support solar, with individual parameters with a low-voltage grid connection) living in United Kingdom, over 18 years old, and not employed by Tesla can participate in the promotional prize draw. Participation is only possible through the Live on Sunshine website.
- Directors, officers, management, and employees (and the immediate families of directors, officers, management, and employees) of Tesla and agencies associated with this promotion, are ineligible to enter.

- By entering this competition, participants agree to our Terms and Conditions and to be contacted by a Certified Installer.
- You can only enter once per person per household. Prizes are awarded at Tesla’s discretion. The following countries are part of the promotional prize draw:

- Once an entrant has entered the competition (in accordance with the Eligibility section of these conditions), they can receive up to 3 additional bonus entries, one for each of the following Tesla products purchased and installed during the campaign period:
  - Powerwall 3,
  - Gateway
- If you are selected as a winner, you may be eligible to receive reimbursement for the cost of these products and their installation.

#### 4. The Prize

- 1 winner in United Kingdom will receive a solar system, Powerwall 2 or Powerwall 3 (Depending on the market – See Appendix 1), Gateway, Wall Connector and free use of a Model 3/Y for 10 days.
- Note that the prize does not include obtaining any applicable permits, authorisations, registrations, notifications, exemptions, approvals, and other authorisations obtained from or made with any governmental authority (“Permits”) or associated costs with obtaining such Permits.
- With respect to the Car Hire component of the prize, the prize winner (or their companion) must have a current valid driver’s licence. The car hire is also subject to any terms and conditions specified by the car hire provider. If these requirements are not met, the car hire component of the prize will be forfeited by the prize winner and no cash or alternative prize will be provided in lieu.

#### 5. Winner announcement

- Tesla will conduct a random drawing to choose the promotional prize draw winners. The winners will be chosen through an anonymous and automated data selection process.
- For Germany winners will be selected based on entries and chosen by an independent panel.
- The announcement of the winners will be via email by Friday, May 2nd, 2025.

#### 6. Claiming the prize

- If you are the winner of the prize, you will receive an email or be contacted by a Tesla employee notifying you that you have won and details on how to claim your prize.
- If you won, you have 7 days from the announcement date to claim the prize following the instructions received with the announcement. If you do not claim the prize within this timeframe, your claim will become invalid.
- The prize may not be claimed by a third party on your behalf.
- Tesla will make all reasonable efforts to contact the winner. If the winner cannot be contacted or is not available, or has not claimed their prize within 7 days of contact, Tesla

reserves the right to discard that entry and to draw another winner on Friday, May 9th, 2025, who will be given until Friday, May 16th, 2025, to claim the prize.

- Tesla does not accept any responsibility if you are not able to take up the prize.
- No prize will be awarded where any entrant has committed any form of misconduct (as determined by Tesla in its sole discretion).
- The winner can decline the prize by answering the winning email within 3 days.
- Prizes cannot be transferred to someone else or substituted for another prize
- If your prize involves driving a Tesla vehicle, you will need to hold a valid driving licence for the market in which you reside. You will need to agree a standard Test Drive Agreement provided on the day.

## **7. Limitation of liability**

- Insofar as is permitted by law, Tesla, its agents or distributors will not in any circumstances be responsible or liable to compensate the winner or accept any liability for any loss, damage or disappointment, occurring as a result of any entrant entering this competition, taking up the prize, or as a result of any entrant winning or not winning any prize, except where it is caused by the negligence of Tesla, its agents or distributors or that of their employees. Your statutory rights are not affected.

## **8. Data protection and publicity**

- If you are the winner of the competition, you agree that Tesla may use your name, image, and town or country of residence to announce the winner of this competition and for any other reasonable and related promotional purposes.
- You further agree to participate in any reasonable publicity required by Tesla.
