

Win a Weekend Getaway with Tesla

1. The promoter

- a. The promotional prize draw is promoted by Tesla Motors Limited, a company incorporated in England under the number 04384008 and having its registered address at 185 Ashton New Road, Manchester, M11 3DX.

2. The Prize

- a. The prize is the opportunity to take home a Tesla for 72 hours and enjoy a complimentary weekend hotel stay at Aquila, Lake District (subject to availability, up to the value of £1450 per stay, Tesla to book on behalf of winner).

3. The Prize Draw

- a. A winner will be picked randomly from all RSVP between 1st August – 13th October 2025
- b. No monetary contribution of any kind is needed for entry.
- c. Duration: applies to any RSVP or captured details, between 1st August – 13th October 2025

4. Eligibility

- a. Every person living in the UK, over 18 years old, having a full driving licence and not being employed by Tesla can participate in the promotional prize draw.
- b. To enter, simply RSVP 13th October 2025. By entering, participants agree to these T&Cs.

5. Winner announcement

- a. Tesla will conduct a random drawing to choose the promotional prize draw winner. The winners will be chosen through an anonymous and automated data selection process.

6. Claiming the prize

- b. The winner will have 7 days from the date of the email to claim the prize. If you do not claim the prize within this timeframe, your claim will become invalid.
- c. The prize may not be claimed by a third party on your behalf.
- d. Tesla will make all reasonable efforts to contact the winner. If the winner cannot be contacted or is not available, or has not claimed their prize within 7 days of contact, Tesla reserves the right to offer the prize to the next eligible entrant selected from the entries that were received.
- e. Tesla does not accept any responsibility if you are not able to take up the prize.
- f. No prize will be awarded where any entrant has committed any form of misconduct (as determined by Tesla in its sole discretion).
- g. Tesla can, at its discretion, make decisions on prize declining, transfer or prize exchange

- h. The winner can decline the prize by answering the winning email within 3 days.

- i. Prizes cannot be transferred to someone else or substituted for another prize

- j. If your prize involves driving a Tesla vehicle, you will need to hold a valid driving licence for the market in which you reside. You will need to agree a standard Test Drive Agreement provided on the day.
